In my life, I cared for my father Russell as he progressed through the later stages of bladder cancer, a condition that was treatable but that spiraled out of control since he set his own health care aside while caring for my mother, Velma. Mom had Alzheimer's. When they came to live with me in the fall of 2007, he was in the end stages of cancer and Mom was in the middle stages of Alzheimer's. My brothers and I cared for them. When my father died in 2008, I experienced caregiving for my mother and ultimately went through the process of searching out appropriate residential care. I cared for and advocated for my mom until she died in January, 2015.
